### 1. LICENSE

By receiving, opening the file package, and/or using Perspective Tools 2 ("Software") containing this software, you agree that this End User User License Agreement (EULA) is a legally binding and valid contract and agree to be bound by it. You agree to abide by the intellectual property laws and all of the terms and conditions of this Agreement.

Unless you have a different license agreement signed by Sergey Kritskiy your use of Perspective Tools 2 indicates your acceptance of this license agreement and warranty.

Subject to the terms of this Agreement, Sergey Kritskiy grants to you a limited, non-exclusive, non-transferable license, without right to sub-license, to use Perspective Tools 2 in accordance with this Agreement and any other written agreement with Sergey Kritskiy. Sergey Kritskiy does not transfer the title of Perspective Tools 2 to you; the license granted to you is not a sale. This agreement is a binding legal agreement between Sergey Kritskiy and the purchasers or users of Perspective Tools 2.

### 2. DISTRIBUTION

Perspective Tools 2 and the license herein granted shall not be copied, shared, distributed, re-sold, offered for re-sale, transferred or sub-licensed in whole or in part except that you may make one copy for archive purposes only. ### 3. USER AGREEMENT

#### 3.1 Use
